ESTABLISHING THE COMPOSITION OF THE REGIONAL ETHICS COMMITTEE FOR
HUMAN HEALTH RESEARCH IN THE NORTH-WEST REGION.

THE MINISTER OF PUBLIC HEALTH,

Mindful of the Law No. 96/03 of 4 January 1996 on the framework law in the domain of health;
Mindful of the Decree No. 02011/408 of 9 December 2011 on the organisation of the government;
Mindful of the Decree No. 2011/409 of 09 December 2011 appointing a Prime Minister Head of Government;
Mindful of the Decree n°2011/410 of 09 December 2011 on the appointment of the Government;
Mindful of the Decree n°2013/209 of 19 August 2002 on the organisation of the Ministry of Public Health;
Mindful of the Order N°0977/A/MINSANTE/SESP/SG/DROS of 18 April 2012 on the creation, organisation and functioning of the Human Health Research Ethics Committees under the authority of the Ministry of Health;
Mindful of the Order No. 0286/D/MSP/CAB of 5 July 2004 on the creation of a Scientific and Strategic Consultative Commission on Health Research at the Ministry of Public Health;
Mindful of the Order No. 0689/D/MINSANTE/SG/DROS of 29 July 2009 laying down the conditions for the issuance of the Administrative Authorisation for Research in Human Health in Cameroon;
Mindful of the Circular letter N°D36-13/LC/MINSANTE/SG/DROS/YC of 9 February 2011 on the implementation of Operational Health Research in Cameroon;

Considering the necessity of service;

DECIDES :

ARTICLE 1 - The present Order establishes the composition of the Regional Ethics Committee for Human Health Research of the North-West Region, hereinafter referred to as "North-West CERSH"

ARTICLE 2 - The North-West CERSH is composed as follows:

2. Dr AMBE Lionel, Medical Doctor;
3. Dr OKWEN Patrick MBAH, Medical Doctor;
4. Dr TATA Elvis FON, Social scientist;
5. Mr. SHAIBU BABAYO ISYAKA, Member of the community;
6. Rev MABU NKIMI Andreas, Representative of religious denominations;
7. Mm TALLA Emmanuella, Specialist in basic sciences.

Alternate members

1. Dr ACHUO Ascencius, Medical Doctor;
2. Mme VUCHAS Comfort YUGAH, Social scientist;
3. Mr. UMAROU PILA, Representative of religious denominations;
4. Mr. Victor FUNDOH, Specialist in basic sciences;
5. Barrister FET SAMA Aloysius, Specialist in basic sciences.

ARTICLE 3 - The term of office of members of the North-West CERSH is three (03) years, renewable twice (02).

ARTICLE 4 - The duties of a member of the North-West CERSH are incompatible with membership of any other ethics committee in Cameroon.

ARTICLE 5: (1) The North-West CERSH shall have a period of eight (08) days from the signing of this decision to organise its first meeting.

(2) The purpose of the said meeting shall be to elect its Bureau, under the coordination of the Senior Member.

ARTICLE 6. - This order shall be registered and published wherever necessary.
